
Community Feedback

- Community feedback sources: forums, survey, e-mails
- Issues raised:
 - Overall HHU concerns: school closure, redistricting timeline
 - Safety: Route 9 crossings, availability of sidewalks, specific intersections, etc.
 - Proximity to schools/walkability
 - Specific neighborhood assignments (i.e. Schofield 5, Hardy 2, Bates 2, etc.)
 - Redistricting implementation plan






Upham Options



- Largely avoids district lines crossing Route 9 -Sprague and Hardy components north of Route 9 move to Upham and Bates and Hardy components south of Rte 9 to Sprague
- Moves Schofield and Sprague components to Fiske to relieve those schools while increasing utilization at Fiske
- Components from Fiske, Sprague and Hardy move to Hunnewell
- Up to 7% enrollment differences between all schools





For example: in Map 2, 20% of residential properties in Fiske are under ½ mile.



- Compared to Map 1, this option moves the Bates/Upham boundary to the east keeping areas close to Bates in Bates
- This results in a counterclockwise domino effect moving the Upham boundary to the east, the Schofield boundary to the south, and the Fiske boundary to the west.
- Up to 14% enrollment difference between all schools







 - 3 Schools below 85% and 3 schools above 85%







Hardy Options



- Largely maintains the existing Hardy district adding closest areas to the school from Bates
- Sends areas north of Rte 9 from Upham to Sprague
- Components from Fiske, Sprague and Hardy move to Hunnewell
- Moves Schofield component to Fiske to relieve Schofield while increasing utilization at Fiske
- Up to 9% enrollment difference between all schools





- All of Upham incorporated into Bates reducing the northern areas moving across Rte 9
- This results in a counter-clockwise domino effect moving southern parts of Hardy to Sprague and more areas from Bates to Hardy
- Up to 14% enrollment difference between all schools





 - HARDY 2, 3, and 4 remain at Hardy
 - BATES 2 remains with Bates
 - BATES 7, 8, and 10 remain at Bates
 - SCHOF 5 remains at Schofield
 - SPRAG 4 moves to Fiske
 - Individual addresses shifted
- While responsive to the feedback, the equalization of enrollment capacites are impacted
 - Up to 17% enrollment difference between all schools
