Any applicant for the Wellesley Public Schools who cannot produce required documents in his/her own name must ask the owner or lessee of the property where the applicant lives to complete and sign this legal affidavit and attached **two documents**, one from each line below:

- 1.) A current lease (which includes children’s names), deed, recent mortgage and property tax bill and
- 2.) A recent itemized utility bill (gas, oil, water, electric or cable issued within the past 30 days)

**Section 2: To be completed by the owner, landlord or corporate officer**

In order to attend Wellesley Public Schools, a student must actually reside in the Town of Wellesley. The residence of a minor child is presumed to be the primary legal residence of the parent/guardian who has physical custody of the child. “Residence” is the place where a person dwells permanently, not temporarily, and is the place that is the center of his/her domestic, social and civic life. Temporary residence in the Town of Wellesley solely for the purpose of attending a Wellesley Public School will not be considered residency. Any student found not to reside in the Town of Wellesley will be dismissed from the Wellesley Public Schools. Additional penalties – including fines and legal action – may be imposed on families found to be in violation of the residency policy. This residency policy does not apply to homeless students.
